No. 1	Can I apply for more than one position?	Yes. Candidate may apply for more than one vacancy subject to meeting the eligibility criteria as mentioned in detailed Advertisement. Candidate has to make separate payment against each of the positions against which he/she is applying to.
2	In my degree course only CGPA/CGPI/OGPA/GPA/CPI has been awarded in place of percentage of marks. Can I mention it in application?	Wherever CGPA/CGPI/OGPA/GPA/CPI or letter grade in a Degree is awarded, equivalent percentage of marks should be indicated in the application as per norms adopted by University/ Institute. Candidates will have to attach documentary proof/ certificate to this effect from the Institute/ University while submitting the application form.
3	I have made some mistakes while filling up the application and same has been already submitted.	Applications once submitted cannot be edited. The reputed company is meeting the eligibility criteria for consideration of organization of repute	Kindly note that you are required to produce documentary proof of the reputed organization(s) which is mentioned in your appointment letter(s) or service certificate, if you have already left the company. Documentary proof should be legal, verifiable documents which clearly mentions the Annual Turnover or listing status of the Company
11	I am working on third party rolls of a reputed company. But my third-party company does meet the eligibility criteria for consideration of reputed organization.	Candidate is required to produce documentary proof of the reputed organization(s) on whose direct rolls he/she is working or was working during the given period.
12	I am working in a JV of a State Govt/Central Govt/PSU. Am I required to produce a NOC during selection process?	If your organization where you are currently working or will be working during the selection process, falls under the definition of "State" or if the State Govt/Central Govt/PSU partner has more than 50% shareholding pattern in the Company, then you are compulsorily required to produce a NOC during the selection process, if you get shortlisted

14	What documents I need to attach in support of having relevant experience in terms of Job Role?  I belong to OBC "CREAMY	Candidates need to produce experience certificate wherein their Job role / function / division is mentioned. Candidates may attach Performance Planning / KPI document of their current / Past Job Role for the same The OBC category candidates who belong to "CREAMY
	LAYER". Which category should I select while applying?	LAYER" are not entitled for OBC concession and such candidates have to indicate their category as "General" while filling up TFL application.
15	I belong to OBC (NCL) category and my said certificate is issued in Dec 2020?	Candidates should note that OBC (NCL) certificate should be valid on the date of further selection process in TFL.
		In case the validity of the OBC (NCL) is expired on the date selection process (GD/Personal Interview), the candidate is required to re-apply to Competent Authority and carry the updated issued certificate in prescribed format on the date of the selection process at TFL.
16	Can I mail my application form to TFL Office at Talcher?	No. You need to mail the application form attaching relevant documents only to the designated address as mentioned in Clause no. 8(d) in the detailed advertisement.
17	Where and when will the GD/Interviews be held?	The venue for further selection process against the said recruitment notification will be held at Bhubaneswar tentatively during Oct-Nov 2021.
